A	AN ORDINANCE to amend and reordain Sections 54-28 and 54-29 of the Code of the
City of I	New Orleans, relative to summons in lieu of arrest and citation for municipal ordinance
instead o	of state law violation, to provide that officers shall issue a summons in lieu of arrest for
misdeme	canor violations except under certain enumerated circumstances; to limit officer discretion
to arrest	an individual solely for a misdemeanor violation; to provide that summons or arrest shall
be based	on the equivalent municipal violation if a misdemeanor offense is punishable under
municipa	al as well as state law; and otherwise to provide with respect thereto.
S	ECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY
ORDAII	NS, That Section 54-28 of the Code of the City of New Orleans is hereby amended and
reordaine	ed to read as follows:
"Section	54-28. – Summons by officer instead of arrest and booking.
(1) A	n officer shall issue a written summons and may not make a custodial arrest when citing
a	person solely for a state or municipal misdemeanor violation, except when one of the
fc	ollowing circumstances exists:
	(a) The person does not possess identification issued by any municipal, state,
	territorial, federal, or other governmental authority within the United States; or
	(b) The person makes a statement that indicates an intent to disregard the summons or
	refuses to sign the summons; or

- (c) The person acts in a violent or destructive manner or makes a statement indicating that he or she intends to imminently inflict injury to self or another or damage to property; or
 - (d) The person is a habitual offender, defined as any individual with a criminal history of two or more felony convictions; or five or more felony, misdemeanor, or municipal arrests for any offense.
 - (2) When an officer determines that one of the exceptions enumerated in subsection (1) applies, the officer may use his or her discretion to issue a summons instead of making a custodial arrest for a violation.
- (3) Subsection (1) does not apply when an officer cites a person for a domestic violence violation.
- (4) When an officer effectuates a custodial arrest for a state or municipal misdemeanor violation, the officer shall appropriately fill out all information on the reverse side of the affidavit at the time of arrest in a form to be promulgated by the New Orleans Police Department that describes with specificity the circumstances falling within subsection (1).
- (5) The New Orleans Police Department shall continue to prepare quarterly reports stating the number of custodial arrests made solely for state or municipal misdemeanor violations, the reasons for those arrests, and the number of summonses issued for such violations.
- (6) A defendant has seven days from the time of the issuance of a summons under this section to appear in court to show cause for the failure to appear as defined in Section 54-1 of this Code. Failure to appear within seven days will create the rebuttable presumption that the defendant is guilty of this article. Whoever commits the crime of failure to appear shall be fined not more than \$500.00, or imprisoned for not more than six months, or both."

SECTION 2. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY

- 2 ORDAINS, That Section 54-29 of the Code of the City of New Orleans (previously Reserved) is
- 3 hereby amended and reordained to read as follows:

- 4 "Section 54-29. Citation for municipal ordinance instead of state law violation.
 - (1) Any member of the New Orleans Police Department citing a person for a misdemeanor offense punishable under both Chapter 54 of the City Code and Titles 14 or 40 of Louisiana Revised Statutes shall arrest or issue a summons for the equivalent municipal offense rather

8	than the equivalent state offense as further provided in subsection (2). The decision of
9	whether to issue a summons or arrest shall be made in accordance with the provisions of
10	Section 54-28.
11	(2) The equivalent municipal offenses shall be used instead of the state offenses as follows:
