

Release for 2021 Spring Semester On-Campus Experience Sunday, January 24, 2021 – Friday, March 12, 2021

In consideration of the health risks associated with the global pandemic and the acknowledgement that returning to residence is optional, I have carefully considered all the risks and support my child returning to the residence hall for the 2021 Spring Semester based on the terms outlined by the South Carolina Governor's School of Science & Mathematics (GSSM). My son/daughter and I have read the conditions associated with being back on campus and we agree to all of them. I also understand that GSSM reserves the right to add additional conditions in support of the safety and welfare of the school community. This includes COVID-19 testing as outlined. I acknowledge that I am aware that by returning to residence there are risks to my child including exposure, directly or indirectly, to communicable disease(s) including but not limited to the virus commonly referred to as COVID-19, and/or any mutation or variation thereof. I understand that while GSSM will make reasonable efforts to comply with applicable safety guidelines, GSSM cannot eliminate the risk of exposure to COVID-19, or guarantee that its classrooms, residence halls, and facilities will be free of COVID-19. Accordingly, GSSM cannot and does not warrant, guarantee. or offer assurances that individuals will not be exposed to COVID-19 while on the premises or engaged in school-related activities, or that individuals will not then expose others to COVID-19. I am aware of the risks associated with coming into residence under these circumstances and release, discharge, and hold harmless GSSM, including its employees, Board, agents, and volunteers from any and all liability should my child become ill as result of returning to and participating in the residential instruction program at GSSM or if he/she engages in conduct and behavior that makes him/her especially vulnerable for contracting any illness or injury, especially COVID-19. I also understand if he/she fails to cooperate with the conditions outlined, other specifics that may be later imposed, and/or the GSSM Discipline and Honor Code, my child will likely be required to leave the campus, return to my care, and complete the semester virtually. understand that he/she will also forfeit the opportunity to attend further residencies during the 2021 Spring Semester.
