It has been my pleasure to serve as your District E City Councilwoman for the past three years. While we have faced many trials and challenges, especially in the wake of the COVID-19 pandemic and major weather events, we are undauntingly moving forward.

Over the last three years, District E has had many notable successes in economic and community development. Many blighted district eyesores have been or are now in the process of being crucially transformed. Notably, along the Lake Forest Corridor, we have two commercial shopping centers that have fully been restored and are now open for business. The Lake Forest Towers are expeditiously turning into quality senior apartments. The "Caveman" Highrise Hotel on Chef Menteur Highway is currently under redevelopment. A master developer is close to being selected for the former Six Flag's site. Transformative investments have been made to fully restore Lincoln Beach into a vibrant, family-friendly destination.

With regard to the Lower Ninth Ward, the first grocery store, St. Claude Fresh Market, has finally opened since Hurricane Katrina. Additionally, along the Florida Avenue corridor, the Sankofa Wetland Park and Nature Trail have opened, attracting important commerce and pedestrian traffic. Steady improvements are being made across the entire district to increase the quality of life and spur vital economic development to continue to move District E forward.

CHAPTER 1: BLIGHT REMEDIATION

The city works on blight remediation in several ways through the Departments of Code Enforcement, Parks and Parkways, Sanitation, Public Works, Property Management, Safety and Permits locally, and partnerships with DOTD, EPA LDEQ, and others. While the Council has no enforcement powers regarding violations, we ensure that requests make it to the proper department or agency for resolution and follow-up on constituent requests.

Enforcement of blight remediation happens in many ways across several city departments:

Code Enforcement

- Inspects properties for code violations
- Holds code enforcement hearings to assess fines and fees to noncomplying property owners
- Initiates and coordinates emergency demolitions of hazardous sites
- Manages the Lot Maintenance Program to cut vacant lots across the city

Parks and Parkways

- Maintains city right-of-way's
- Maintains neutral grounds via grass cutting and litter abatement
- Maintains all trees on city-owned properties

Sanitation

- Cleans up illegal dumping
- Places illegal dumping cameras throughout the city
- Coordinates street sweeping efforts on public roads and streets

Public Works

- Cleans catch basins
- Repairs and replaces damaged catch basins
- Tows abandoned vehicles

Property Management

• Monitors and maintains city owned properties

Safety and Permits

- Inspects properties for zoning violations
- Ensures businesses have proper permitting and licenses for operation

Through partnerships with city departments and external agencies, there have been significant reductions in blight throughout the District.

DEMOLITIONS

A total of **139 properties were demolished** in District E since Councilwoman Nguyen has taken office. The demolition of blighted properties effectively cleans up neighborhoods by removing blight, areas for illegal activity, and eradicating hazardous conditions.

2018

- 30 properties in the Lower Ninth Ward were demolished.
- 44 properties in New Orleans East were demolished.

2019

- 15 properties in the Lower Ninth Ward were demolished.
- 26 properties in New Orleans East were demolished.

2020

- 10 properties in the Lower Ninth Ward were demolished.
- 12 properties in New Orleans East were demolished.

2021 (January 1 - April 15)

• So far, 2 properties in the Lower Ninth Ward have been demolished.

CODE ENFORCEMENT HEARINGS

A total of **1,005 property code** enforcement hearings were held since Councilwoman Nguyen has taken office. These hearings are a first step in the blight reduction process, resulting in fines and fees against non-complying property owners.

2018

• 250 Code Enforcement hearings were held for properties in District E.

2019

• 541 Code Enforcement hearings were held for properties in District E.

2020

• 137 Code Enforcement hearings were held for properties in District E <u>Please note</u>: because to the Coronavirus pandemic, the Office of Code Enforcement was reassigned to monitoring regulation compliance, leading to reduced enforcement activities.

2021 (January 1 - May 30)

• So far, 98 Code Enforcement hearings have been held for properties in District E.


CHAPTER 2: INFRASTRUCTURE

Roads and Streets

The Department of Public Works (DPW) and Sewerage and Water Board are jointly working on future projects to improve the streets and drainage systems.

- DPW has invested over \$56 million in District E's roadwork projects since Councilwoman Nguyen took office on May 7, 2018.
- DPW has over \$140 million in budgeted projects.
- DPW and the Sewage and Water Board jointly working on future projects to improve both the streets and drainage system.

The chart below shows the DPW investments in District E by year and a map of all DPW/SWB projects completed, scheduled, and pending in District E.




Map of DPW Projects in District E

CHAPTER 3: ECONOMIC DEVELOPMENT

Development by the Numbers: Construction Investments by Year

Supporting Businesses

The COVID-19 pandemic and major weather events affected many businesses in District E. As a result, our office has been working with the New Orleans Business Alliance to implement the Resilient Corridors Initiative, which is a \$350,000 pilot program to support businesses in the New Orleans East and the Lower Ninth Ward corridor to aid in their recovery.

In addition, our office works closely with the U.S. Small Business Association to share information about various support and funding opportunities, including the Payroll Protection Program and Shuttered Venue Operation Grant.

Our office maintains an "open door" communication policy with businesses in our community, whether there are questions about specific city policies or departments, tax incentives, funding opportunities, or community events.

Encouraging and Welcoming New Businesses

During Councilwoman Nguyen's time in office, over 200 new businesses have opened in District E, bringing vital economic development and jobs. Please see the following page for an illustrative listing of new notable companies.

Notable New Businesses Opened 2018 - 2021 in District E



Iriapak 4120 Poche Ct W, New Orleans, LA 70129

Iriapak, an Italian company founded in 1978, manufactures packaging for home paper products, such as paper towels and tissue. Importantly, they have opened their first North American location with a \$7 million investment in New Orleans East, creating 53 jobs.



The Cosmetology Institute 8460 Morrison Road New Orleans, LA 70127

The Cosmetology Institute is the city's newest training center focused on cosmetology licensing and entrepreneurial development.



Optimus Entertainment 9820 Lake Forest Blvd, New Orleans, LA 70127

Optimus Entertainment is a multi-million dollar indoor family entertainment center with over 24,000 square feet of play area, including exclusive arcade and virtual reality games, a 9-D theater, bumper cars, and two Laser Tag arenas. This entertainment complex additionally contains 42,000 sq ft of retail space.



Ochsner Community Health — Brees Family Center 5950 Bullard Ave, New Orleans, LA 70128

Ochsner's first health clinic with vital primary and specialty care services to residents is in District E.



Tate Etienne & Prevost (TEP) Center 5909 St Claude Avenue, New Orleans, LA 70117

A long-vacant historic site of integration, McDonogh 19 Elementary School, is now being revitalized into the Tate Etienne & Prevost Center. This location marked the first African-Americans Leona Tate, Gail Etienne, and Tessie Prevost, who attend a formerly white-only school in Louisiana. This renovated building will include a Civil Rights Museum and educational exhibition spaces dedicated to the desegregation of New Orleans Public Schools, Civil Rights, and restorative justice. This development will also contain affordable senior housing.



Blucid Floral 5113 St Claude Ave, New Orleans, LA 70117

In 2020, Blucid Floral opened in the Lower Ninth Ward as a fully licensed florist and floral design shop providing high-quality custom floral arrangements.



St. Claude Fresh Market 5330 St Claude Ave, New Orleans, LA 70117

The St. Claude Fresh Market is the first fresh food grocery store to open in the Lower Ninth Ward since Hurricane Katrina. This store provides vital nutrition and food access.

Transformative Redevelopments

In addition to new businesses, several transformational development projects across the district will provide quality housing and recreation activities. These projects will seriously change the landscape of District E and serve as vital catalysts for future growth. These transformative redevelopments are not an exclusive listing but an illustrative example of the work being done to move District E forward.



The Reveal

This \$42 million investment by Commonwealth Companies will provide 150 new housing units for families in a gated community with a business incubator and commercial spaces on site. The Reveal located at 13707 Chef Menteur Highway will be a modern, safe, and quality place for families.



Sanfoka Wetland Park and Nature Trail

The Sanfoka Wetland Park was partially developed in 2017 in partnership with the Sewerage and Water Board and the City of New Orleans. In April 2021, the Council formally approved a cooperative endeavor agreement (CEA) between the City and Sanfoka to develop all 40 acres of the site.



Lake Forest Manor

This \$32 million investment by TKTMJ, Inc. will restore the former Lake Forest Towers, providing 200 units of senior housing at 10101 Lake Forest Blvd. The project is slated to be completed in late 2021.



High Rise Hotel

Blighted since Hurricane Katrina, this nationally historic hotel, the former Holiday Inn Hotel, will be redeveloped into a mixed-use commercial and residential property with a \$7 million investment. This development will contain commercial spaces on the first floor, including a restaurant and retail. Market-rate housing will comprise the upper floors with 144 units. The High Rise Hotel will be complete in the Fall of 2021.

2. Lake Forest Manor - 10101 Lake Forest Blvd. - \$20,728,186

Substantial rehab of 16 story, multi-family residential structure with 200 dwelling units.

Interior renovation of existing building to accommodate senior housing apartments and museum exhibition space.

4. Highrise Hotel - 6324 Chef Menteur Hwy. - \$7,000,000

CHAPTER 4: PUBLIC POLICY

One of the primary functions of the City Council is to create policies and ordinances for the benefit and welfare of the City of New Orleans. While this is not an exhaustive list, the ordinances and resolutions below are meant to illustrate how Councilwoman Nguyen has toughened the city's blight remediation ordinances; enhanced funding for our local, minority-owned, small businesses; and dissuaded the stereotypical characterization of District E residents.

CAL. NO. 32,852

BY: COUNCILMEMBER NGUYEN

Brief: Ordinance to incorporate recommendations and initiatives contained in the 2018 "Small Box Retail Diversity Study."

What it does: This ordinance had multiple parts, but the high points are:

- 1. Put a moratorium on "small box retail" stores city-wide, which include dollar and discount stores. These stores cannot locate closer than one mile to each other in most of the city and cannot locate closer than two miles in New Orleans East.
- 2. Gave an incentive to grocery stores that dedicate thirty percent (30%) or more of shelf space and display area to fresh or fresh frozen foods who want to locate in food deserts, allowing 5,000 more square feet by right in areas such as Chef Menteur Highway, Downman Road, Bundy Road, and other areas.
- 3. Reduced restrictions on planting crops in residential neighborhoods, further allowing people to grow their own fresh food.

CAL. NO. 33,055

BY: COUNCILMEMBERS WILLIAMS & NGUYEN

Brief: Ordinance to modify the user permissions and standards for child daycares in non-residential districts within the CZO of the City of New Orleans to ensure increased availability of child day care centers within New Orleans

What it does: Childcare is an important factor for many families, yet the city had heavy restrictions on childcare center locations and outdated regulations not aligned with state laws.

- 1. Updated all city regulations to match that of the state.
- 2. Allowed more childcare centers in commercial areas throughout the city, hopefully opening more seats for childcare in the future.

CAL. NO. 33,225

BY: COUNCILMEMBERS NGUYEN & MORENO

Brief: Ordinance to rename the Disadvantaged Business Enterprise (DBE) program to the Equitable Business Opportunities (EBO); clarify the application of the equity goal requirements for all contracts executed by the city, as well as agencies, corporations, boards, and commissions subject to city requirements.

What it does: This ordinance revised the city's DBE, renaming it to remove the stigma of these businesses being considered disadvantaged.

- 1. This ordinance clarified what city agencies and departments were responsible for meeting the city's equity goal, the percentage of DBE utilization needed per contract.
- 2. If a city agency or department misses an equity goal, a report on why the goal was missed and actions to meet it in the future is required.
- 3. This ordinance ensures transmission of any equity goal waiver requests for city executed contracts to the Council and the public via an annual report.
- 4. These changes will ensure that more public dollars stay in our local communities with our minority and women-owned businesses.

R-21-44

BY: COUNCILMEMBERS NGUYEN AND BANKS

Brief: Calls to the media to change their blanket use of the term "New Orleans East" when describing events, incidents, and crime anywhere east of the Industrial Canal and instead reference individual neighborhoods, subdivisions, streets, or intersections.

What it does: This resolution seeks to encourage all media and news reporting outlets to reference individual neighborhoods, subdivisions, streets, or intersections.

- 1. Councilwoman Nguyen understands that the categorical stigmatization of "The East" dissuades community investment, erodes civic pride, and erects barriers to economic development.
- 2. As a follow-up to this resolution, Councilwoman Nguyen is working on a neighborhood mapping project to be a resource for referencing each vibrant and unique community.

Ordinance to authorize a Cooperative Endeavor Agreement between the City and Baptist Community Health Services to provide healthcare at the Sanchez Center

CHAPTER 6: CRIME & PUBLIC SAFETY

Crime is a major concern for many residents. Councilwoman Nguyen has coordinated several programs to improve public safety in District E. This includes monthly Community Crime Prevention Workshops, assisting residents in creating neighborhood watch programs and events for Night Out Against Crime, supporting the implementation of innovative solutions, and allocating additional funding for safety cameras throughout the District.

In 2020, voters approved the sale of a \$300 million bond to fund permanent capital improvements and investments city-wide. Councilwoman Nguyen worked closely with the Capital Projects Administration to assure District E received capital to fund projects that benefit our district.

CHAPTER 8: THE ROAD FORWARD

We have many projects and investments under development in District E. Below are pending developments and initiatives that will continue to move the District forward. This is not a complete list, but rather an overview of some of the transformative developments coming to District E.

Louisiana Space Campus

Through partnerships between Louisiana Economic Development, the Michoud Assembly Facility, State of Louisiana, and City of New Orleans, plans are in the work for a 50-acre Louisiana Space Campus at NASA in New Orleans East.

Brownfield's Program Funding

Councilwoman Nguyen's office is working with the Regional Planning Commission, Louisiana Department of Environmental Quality, and Environmental Protection Agency to secure brownfield remediation funding for sites in the Lower Ninth Ward and New Orleans East.

Former Six Flags Site Revitalization

The ongoing RFQ process will hopefully result in the selection of a long-term development partner for the former Six Flags site.

Lincoln Beach Restoration

Councilwoman Nguyen has allocated funding via the Capital Improvements Plan to fund community-led design processes for Lincoln Beach following the completion of the environmental surveys, and then plans to allocate additional funding for development of the site following design completion.

Stormwater Retention Credit Program

This innovative policy will create further stormwater retention in our city and restructure our current stormwater management program. At this time, developers can pay a one-time fee for stormwater management which will offset their development project. This program will encourage developers to fund stormwater management projects that protect our city's infrastructure long-term rather than paying a one-time penalty fee.

Greater St. Stephen Full Gospel Baptist Church Eljeanette White Parent Child Center

The \$3.8 million Eljeanette White Parent Child Center coming to Lake Forest Boulevard is set to be complete by March 2022 and will be a community center housing childcare and other services for parents, as well as arts and technology programs and an auditorium.

St. Claude Avenue Louisiana Main Street Program

Our office is working with the Lower Ninth Ward Economic Development District and other stakeholders to secure Louisiana Main Street funding for assistance in revitalizing the St. Claude corridor.

Blackstar Diversified

Blackstar Diversified is a minority owned small business certified electrical distribution and traffic controls systems integrator that recently located their Louisiana headquarters on Chef Menteur Highway at a formerly unused warehouse. The business will be building out the existing site, expanding their Louisiana contracts, and creating high-paying and skilled jobs in the area.

Former Lake Forest Plaza Site

There has been movement regarding the former Lake Forest Plaza site. One of the former owners is seeking to pay off the debts associated with the property and bring it back into commerce.

Sideshow Props

Currently located in Slidell, Side Show Props and Art Gallery is moving to District E on Chef Menteur Highway. They just signed an agreement to purchase the property and will begin cleanup of the currently unused site within the next couple of months. They make and rent a variety of props and sets used in the film industry and also use their space and props to create memorable events on site.

Truck Route Enforcement

The Department of Public Works is placing signage throughout the Lower Ninth Ward and New Orleans East to ensure that 18-wheelers and oversized vehicles are adhering to the approved truck routes.

STEM NOLA Training Center

STEM NOLA is moving to the district and creating a 42,000 square foot Innovation Hub to teach and expand high quality STEM education to all students. The site will include specialized STEM-exploration lab space, classrooms, meeting spaces and serve as the headquarters for STEM NOLA's ongoing programming.

Former Lowe's building

Lowe's continues to actively seek a developer to transform the over 90,000 square foot building on Read Boulevard. Several potential groups have been engaged in revitalizing the site.

Neighborhood Mapping

Councilwoman Nguyen's team is working on an interactive map to outline the unique neighborhoods and communities in New Orleans East and the Lower Ninth Ward to serve as a reference for the district.

Safety Cameras

Through bond funding, Councilwoman Nguyen secured \$800,000 to place additional safety cameras in District E. When the bond is sold, these cameras will be installed around the district in locations proposed by NOPD and community members.

Lineage Logistics Expansion

Lineage Logistics will build a \$42 million expansion of its Jourdan Road cold storage facility in New Orleans East, where Lineage plans to create 50 new direct jobs. The project is projected to be complete in the second quarter of 2022, and the company will begin hiring for its new jobs in early 2022.

BRIGHTER FUTURE
